

RESOLUTION NO. 6861

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL ELECTION HELD MARCH 14, 2006; DECLARING THE ELECTION OF TWO CANDIDATES FOR THE OFFICE OF CITY COUNCIL MEMBER; AND DECLARING TWO CANDIDATES FOR THE OFFICE OF CITY COUNCIL MEMBER IN THE RUNOFF ELECTION TO BE HELD MAY 16, 2006.

WHEREAS, the City of Scottsdale, Maricopa County, Arizona, held a General Election on March 14, 2006, pursuant to Article 9, Section 1 of the Scottsdale City Charter, for the purpose of electing three council members for the City of Scottsdale; and

WHEREAS, ARS § 16-642 requires that the City Council canvass the returns of the election no later than fifteen (15) days following the election; and

WHEREAS, the Council of the City of Scottsdale, having canvassed the returns of the General Election, finds the returns to be as stated in this resolution,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale as follows:


1. The results of the canvass having been determined, the official canvass of the City of Scottsdale General Election held on March 14, 2006 is as follows:
 - a) A summary of the number of votes cast in each district for each candidate for the office of council member is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A precinct group detail of the number of ballots cast and number of rejected ballots by district is shown on Exhibit B, which is attached and incorporated by this reference.
2. Wayne Ecton and Tony Nelssen, having received more than a majority of the votes cast at the General Election for the office of council member, are declared to be elected to that office.

3. The following named candidates, having received the greatest number of votes cast in the General Election, which number was less than the majority of all votes cast, will be candidates at the Runoff Election, to be held on May 16, 2006 for one council seat to be filled:

Kevin Osterman




