

RESOLUTION NO. 3027

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL ELECTION OF MARCH 22, 1988, DECLARING THE ELECTION OF TWO (2) CANDIDATES TO THE OFFICE OF COUNCILMAN AND DECLARING THE OFFICIAL CANVASS OF VOTES.

WHEREAS, the Municipal Election of the City of Scottsdale, Arizona was held on March 22, 1988 pursuant to the City Charter, for the purpose of electing two Councilmen of the City of Scottsdale; and

WHEREAS, the Council of the City of Scottsdale, Maricopa County, Arizona, having canvassed the returns of said election and find such returns to be stated herein below,






