

RESOLUTION NO. 11645

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE SPECIAL ELECTION HELD NOVEMBER 5, 2019.

WHEREAS, pursuant to Article 9, Section 1, of the Scottsdale City Charter, the City of Scottsdale held a Special Election on November 5, 2019, for the purpose of submitting three ballot measures to the voters of Scottsdale; and

WHEREAS, on April 15, 2019, the Mayor and City Council adopted Resolution No. 11434 titled, "A resolution of the Council of the City of Scottsdale, Arizona, ordering and calling a Special Election to be held in and for the City of Scottsdale, Arizona on Tuesday, November 5, 2019, to submit to the qualified electors thereof the questions of authorizing the issuance and sale of up to \$319,000,000 principal amount of general obligation bonds in one or more series, as tax-exempt or taxable bonds; designating or providing for the manner in which the City Clerk shall conduct the election, Spanish translation of election materials, deadline for voter registration, and type of voting system to be used; and authorizing a bond oversight committee"; and

WHEREAS, three bond questions were submitted to the Scottsdale voters at the November 5, 2019 Special Election as Question 1, Question 2, and Question 3; and

WHEREAS, A.R.S. § 35-454 requires the City Council to meet within twenty (20) days after the election to canvass the votes cast and certify the results of the bond election; and

WHEREAS, the City Council, having canvassed the returns of the November 5, 2019 Special Election, finds the returns to be as stated in this resolution;

NOW THEREFORE BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the election having been determined, the official canvass of the City of Scottsdale Special Election held on November 5, 2019 is as follows:
 - a) A summary of the number of votes cast in each consolidated precinct for each question is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A consolidated precinct group detail of the number of rejected ballots by consolidated precinct is shown on Exhibit B, which is attached and incorporated by this reference.
2. Question 1, which sought voter authorization to sell up to \$112,600,000 general obligation bonds for parks, recreation, and senior services, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters of the City of Scottsdale.

3. Question 2, which sought voter authorization to sell up to \$112,300,000 general obligation bonds for community spaces and infrastructure, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters of the City of Scottsdale.
4. Question 3, which sought voter authorization to sell up to \$94,100,000 general obligation bonds for public safety and technology, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters of the City of Scottsdale.



RESOLUCIÓN NÚM. 11645

UNA RESOLUCIÓN DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, ARIZONA, DECLARANDO EL CONTEO OFICIAL DE VOTOS EMITIDOS EN LA ELECCIÓN ESPECIAL DE LA CIUDAD DE SCOTTSDALE LLEVADA A CABO EL 5 DE NOVIEMBRE DE 2019.

CONSIDERANDO QUE, en conformidad con el Artículo 9, Sección 1, de los Estatutos de la Ciudad de Scottsdale, la Ciudad de Scottsdale llevó a cabo una Elección Especial el 5 de noviembre de 2019, con el propósito de presentar tres medidas de boleta a los votantes de Scottsdale; y

CONSIDERANDO QUE, el 15 de abril de 2019, el Alcalde y el Concejo de la Ciudad adoptaron la Resolución Núm. 11434 titulada, "Una resolución del Concejo de la Ciudad de Scottsdale, Arizona, ordenando y convocando a una Elección Especial en y para la Ciudad de Scottsdale, Arizona a llevarse a cabo el martes 5 de noviembre de 2019, para presentar a los electores con derecho a voto de la misma las preguntas sobre autorización de la emisión y venta de una cantidad principal de hasta \$319,000,000 de bonos de obligación general en una o más series, como bonos exentos de impuestos o gravables; encargando o proporcionando la forma en que la Secretaria de la Ciudad llevará a cabo la elección, la traducción al español de los materiales electorales, la fecha de vencimiento para la inscripción de votantes, y el tipo del sistema de votación a usarse; y autorizando un comité de supervisión de bonos"; y

CONSIDERANDO QUE, las tres preguntas sobre bonos fueron presentadas a los votantes de Scottsdale en la Elección Especial del 5 de noviembre de 2019 como Pregunta 1, Pregunta 2, y Pregunta 3; y

CONSIDERANDO QUE, A.R.S. § 35-454 requiere que el Concejo de la Ciudad se reúna dentro de los veinte (20) días siguientes a la elección para contar los votos emitidos y certificar los resultados de la elección de bonos; y

CONSIDERANDO QUE, el Concejo de la Ciudad, habiendo realizado el conteo de los votos recibidos de la Elección Especial del 5 de noviembre de 2019, considera que los resultados son los indicados en esta resolución;

AHORA POR LO TANTO QUEDA RESUELTO por el Concejo de la Ciudad de Scottsdale lo siguiente:

1. Los resultados de la elección han sido determinados y el conteo oficial de la Elección Especial de la Ciudad de Scottsdale llevada a cabo el 5 de noviembre es el siguiente:
 - a) En el Anexo A, que se adjunta e incorpora mediante esta referencia, se muestra un resumen del número de votos emitidos para cada pregunta en cada recinto consolidado.
 - b) En el Anexo B, que se adjunta e incorpora mediante esta referencia, se muestra un detalle del grupo de recintos consolidados con el número de boletas rechazadas por recinto consolidado.

2. Pregunta 1, que buscaba la autorización de los votantes para vender hasta \$112,600,000 en bonos de obligación general para parques, recreación y servicios para ciudadanos de la tercera edad, habiendo recibido un número de votos que superó la mayoría de los votos emitidos, fue aprobada por los votantes con derecho a voto de la Ciudad de Scottsdale.
3. Pregunta 2, que buscaba la autorización de los votantes para vender hasta \$112,300,000 en bonos de obligación general para espacios e infraestructura para la comunidad, habiendo recibido un número de votos que superó la mayoría de los votos emitidos, fue aprobada por los votantes con derecho a voto de la Ciudad de Scottsdale.
4. Pregunta 3, que buscaba la autorización de los votantes para vender hasta \$94,100,000 en bonos de obligación general para seguridad pública y tecnología, habiendo recibido un número de votos que superó la mayoría de los votos emitidos, fue aprobada por los votantes con derecho a voto de la Ciudad de Scottsdale.
