WHEREAS, the City Council, having canvassed the returns of the November 8, 2016 General/Special Election, finds the returns to be as stated in this resolution;

 - b) A precinct group detail of the number of rejected ballots by precinct is shown on Exhibit B, which is attached and incorporated by this reference.
